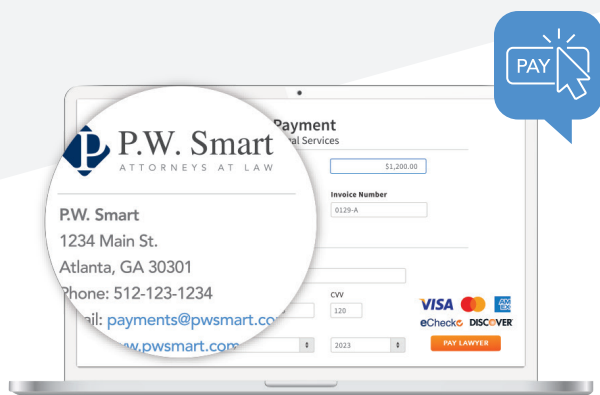

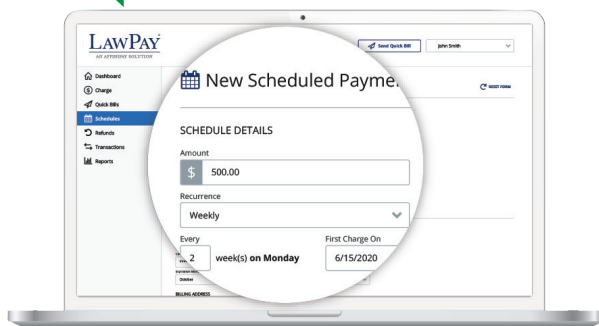
## CUSTOMIZED PAYMENT PAGES

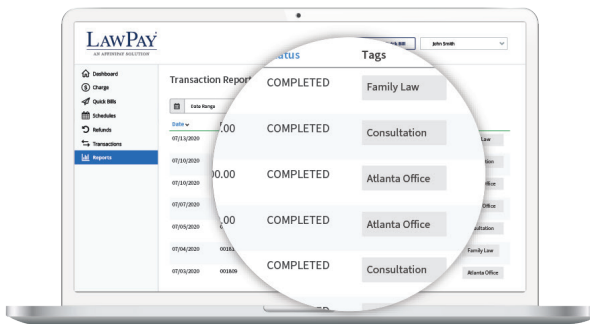
