## COPYRIGHT AGREEMENT

The New York State Bar Association (NYSBA) has agreed to consider the publication of your article entitled:

**Grant of Rights:** In consideration for publication of the Work and the anticipated publicity resulting therefrom, you grant NYSBA the following rights:

all worldwide right, title, and interest in the Work, including but not limited to: I. All copyrights and other intellectual property rights, for all purposes, in all languages and in any form or media, whether now known or hereafter developed; 2. The exclusive right of first publication of the work; 3. The right to republish the work; 4. The right to license the rights granted hereunder to third parties, including the right to license the work for publication or distribution in any form or media, whether now known or hereafter developed; and 5. The right to use your name, likeness, photograph and biographical material in connection with the advertising, publicity or promotion of the Work.

Use by Author: Following first publication of the Work by NYSBA you will have the right to a perpetual, royalty free, worldwide license to use the work for your own personal use and to promote your employer, law firm, or law practice. This use includes permission to make and distribute print or digital copies of the work to friends, colleagues, clients, or on your employer or law firm website or social media promoting your law practice without further notice to or approval from NYSBA. Any such copy must contain the following notice "Reprinted with permission from the New York State Bar Association © 2023."

**Republication:** If you seek to have the Work republished in another publication you may do so upon prior written notice and approval from NYSBA. Such approval shall not be unreasonably withheld when republication is more than 90 days after the original publication date. Request for approval of republication earlier than 90 days may be requested at any time. All notices and requests for approval shall be sent to

It is recommended that any request for approval be submitted at least 5 business days prior to any republication submission date.

**Editing:** The author authorizes the New York State Bar Association's editorial staff to edit and revise the Work prior to publication. It is understood that any changes related to, for example, grammar, punctuation, and stylistic matters, will be made without the need for author approval. The author will have the opportunity to review any substantive changes after copy editing.

Warranty: You warrant that you are the sole author of the Work, that the Work is original with you, that its publication will not infringe on the rights of others, and that you have full power to make this agreement.

Previous Publication and Permission: You warrant that the Work has not been published elsewhere in whole or in part (except as may be set out in a rider attached hereto) and that no agreement to publish the Work or any part or version thereof is outstanding. Should the work contain any material that requires written permission for inclusion in the Work, you represent that you have obtained such permission in writing from the copyright owner.

**Jurisdiction:** This letter contains the entire and complete understanding of the parties and shall be governed by the laws of the State of New York, without reference to conflicts of laws and without regard to its location of execution and performance. Any equitable or civil action arising under this letter shall be heard in the federal or state courts located in Albany County, State of New York and the Author consents to the venue and personal jurisdiction of such courts. This agreement can only be changed by an agreement in writing signed by all parties.
