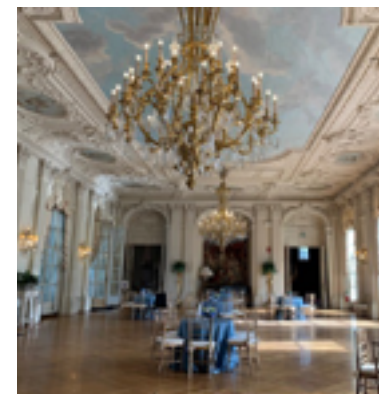
What will I get from participating?
